(“Agreement”)

1. IN CONSIDERATION of being permitted to participate in any way in Midwest Badminton Club and Training Center (“MBC”) sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:

ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of badminton activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the activity.
3. FULLY UNDERSTAND that (a) Badminton ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH (“RISKS”) ; (b) these Risks and dangers may be caused by me and or/my child’s own activities, the condition in which the activities takes place, or THE NEGLIGENCE OF THE “RELEASES” NAMES BELOW; (c) there may be OTHER RISK: AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMANGES I and/or my minor child incur as a result of my participation in the activity.

HERE BY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE MBC, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and leasers of premises on which the activities take place, (each considered one of the “RELEASEES” herein) FROM ALL LIABILITY CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OF ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE “RELEASEES” OR OTHERWISE, INCLUDING NEGLIGENCE RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVE OF LIABILITY, ASSUMPTIONS OF RISK, AND INDEMINITY AGREEMENT I and/ or minor child, or anyone on my INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
